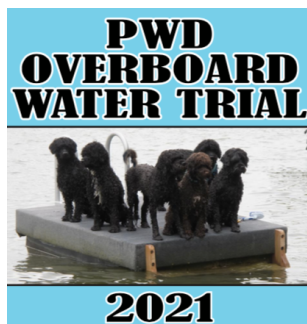

## **COVID-19 GUIDELINES**

Do not attend if you are ill or have been exposed to those who are. Respect physical distancing requirements (an oars length apart - or 6 feet) Follow CDC Guidelines to wash hands often and/or use sanitizer. Bring your own sanitizing wipes, disinfectants and other supplies to wipe down your hotel room when you arrive and to keep your trial site set-up area clean and sanitized.

Practices will be in place to minimize the handling of water work equipment by those other than the handler and to comply, when possible, with physically distancing. Please set up tents and kennels per physical distancing rules.

## **WATER TRIAL SITE**

The water trials will be held at Morse Park and Beach, Noblesville, IN. Morse Park and Beach is located approximately 15 miles North of Indianapolis, and a 3 hour drive from the South side of Chicago. The trial grounds will be available on Saturday and Sunday from 8:00 AM until the trial begins and from the conclusion of scheduled events until dusk.

## **DIRECTIONS TO SITE DIRECTIONS FROM THE NORTH VIA I-65**

Exit I-65 at State Rt. 47 (exit #146). Take State Rt. 47 East approx. 20 miles to State Rt. 38 in the town of Sheridan, turn right. Take State Rt. 38 Southeast approx. 10 miles to Hague Rd (stop light). Turn left (North)

onto Hague Road approx. 1 mile to 196th Street. Turn left (West) to the Park.

## **DIRECTIONS FROM THE NORTH VIA I-69**

Exit I-69 at State Rt. 38 (exit #219). Take Rt. 38 West approx. 12 miles to State Rt. 37 in Noblesville. Turn right (North) onto Rt. 37 approx. 1 mile to 186th Street. It is also marked Field Drive. Turn left (West) onto 186th Street approx. 1 mile to State Rt. 19 (stop light). Turn right (North) onto Rt. 19 to 196th Street. Turn left (West) onto 196th Street approximately 1 mile to Park. Starting in Indianapolis, take I-465 to I-69 North. Take I-69 North to State Rt. 37 (exit #205). Take Rt. 37 North approx. 7 mile to 186th Street. It is also marked Field Drive. Turn left (West) onto 186th Street approx. 1 mile to State Rt. 19 (stop light). Turn right (North) onto Rt. 19 to 196th Street. Turn left (West) onto 196th Street approximately 1 mile to Park.
